1. Introduction

This is our data protection and privacy policy that explains who we are, how we process personal data and, if you are the subject of any of the personal data concerned, what rights you have and how to get in touch with us if you need to.

2. Who we are

4. Lawful bases for processing

Under UK data protection law, we must have a "lawful basis" for collecting and using your personal information. There is a list of possible lawful bases in the UK GDPR. We process your personal data under the following lawful bases, as appropriate:

• Consent: Where you have given us permission after being informed. You may withdraw your consent at any time.



- Contract: Where processing is necessary to enter into or carry out a contract with you.
- Legal obligation: Where processing is required to comply with the law.

6. How long we keep information

We store your data for as long as it is necessary for the purposes set out above (e.g. for as long as we have, or need to keep a record of, a relationship with a business contact, or for recruitment purposes), after which it will be deleted or archived except to the extent that it is necessary for us to continue to process it for the purpose of compliance with legal obligations to which we are subject or for another legitimate and lawful purpose.

7. Who we share information with

8. Sharing information outside the UK

Our use of service providers involves some processing or storage of personal data in countries outside the UK or European Economic Area (EEA). An example of this is where we utilise cloud-based software as part of our operations (software as a service). We ensure that such a transfer complies with the conditions for transfers stipulated by applicable data protection law. We ensure appropriate safeguards are in place and ensure providers have appropriate accredited information security standards in place.

9. Cookies and Tracking Technologies

What Are Cookies?

Cookies are small text files stored on your device when you visit our website. They help us make the website function properly, provide better user experience, and understand how the website performs.

How We Use Cookies

We use both first-party and third-party cookies for several purposes:

- Essential cookies: Necessary for the website to function and do not collect personally identifiable data.
- Statistics cookies: Help us understand how visitors interact with our website, which pages are visited, and how the website performs.
- Marketing cookies: Used to personalise advertisements and track the effectiveness of ad campaigns. Information may be shared with third-party providers.
- Functional cookies: Enable non-essential features such as embedded videos or social media sharing.

Tracking Technologies

We may use other tracking technologies (such as web beacons and pixels) to collect information about your browsing behaviour, device information, and usage patterns. This helps us improve our services and tailor content to your interests.

Managing Cookies

You can control and manage cookies through your browser settings. You may also withdraw your consent for non-essential cookies at any time. For more information, please refer to our Cookie Policy or contact us using the details below.



10. Your Rights

You have the following rights in relation to personal data relating to you that we process:

- You may request access to the personal data concerned.
- You may request that incorrect personal data that we are processing be rectified.
- In certain circumstances (normally where it is no longer necessary for us to continue to process it),
 you may be entitled to request that we erase the personal data concerned.
- Where we are processing your personal data for marketing purposes or otherwise based on our legitimate interests, you may in certain circumstances have a right to object to that processing.
- Where we are processing personal data relating to you based on your prior consent to that processing, you may withdraw your consent, after which we shall stop the processing concerned.

To exercise any of your rights (including withdrawing relevant consents or obtaining access to your personal data), you should contact us as set out below. We will respond without undue delay and within one month.

If you have a complaint about any processing of your personal data being conducted by us, you can contact us as set out below or lodge a formal compliant with the Information Commissioner.

If you remain unhappy with how we've used your data after raising a complaint with us, you can also complain to the ICO.
